- 18 May: Regular administrative duties.
- 19 May: C.G., C/S, G-2, G-3, sections established advance C. P. in Formia, Italy. Organization still operating in three echelons.

Division offices and billets for personnel located in buildings. Weather fair. All moves executed without accident.



Band moved from 85th Division rest area one mile N.E. Mondragone, Italy to Formia, Italy. Left old area 1300 arrived Formia 1500.

No change in location of echelons. Weather Fair and hot. 31 Usual administrative duties.
